<b>LEGAL BASIS FOR THE STATISTICAL SURVEY</b>	<p>Regulation (EU) 2019/1700 of the European Parliament and the Council of 10 October 2019 establishing a common framework for European statistics relating to persons and households, based on data at individual level collected samples, amending Regulations (EC) No 08/2004, (EC) No 452/200 and (EC) No 1338/2008 of the European Parliament and of the Council, and repealing EC) No 1177/2003 of the European Parliament and of the Council and Council Regulation No 577/98. <b>OBJECTIVE, TYPE AND SCOPE OF THE STATISTICAL SURVEY</b>	<p>The purpose of the survey is to produce and publish statistical information on the employment of the population, to assess the number of employed, unemployed and economically inactive population, their distribution by age, sex, education, etc.</p> <p>It is a sample statistical survey. Sample covers 8,000 households. Statistical data are collected by means of a population survey.</p>
<b>TIME AND PLACE OF PUBLICATION OF STATISTICAL INFORMATION</b>	<p>No later than 43 days after the end of the reference quarter, in the quarterly news release “Employment and Unemployment”; in the statistical publication “Labour Market in Lithuania”; on the Official Statistics Portal at <a href="http://osp.stat.gov.lt">osp.stat.gov.lt</a>.</p>
